



ELECTROLYSIS CEU LIVE HOURS WEBINAR SYLLABUS

Description

This Continuing Education Unit (CEU) course is designed as a comprehensive two-day program delivered via Zoom. Each day consists of a five-hour live webinar session, focusing on essential topics such as Sterilization, Sanitation, Bacteria, and Laser Safety. The curriculum is structured to address both fundamental principles and current laws and regulations, while also exploring up-to-date discussions and real-life examples of workplace safety within a medical spa setting.

Active participation is encouraged, as the webinar will feature group discussions centered around emerging issues and best practices related to safety in both medical and paramedical environments.

- Note: All CEU sessions are conducted virtually. There are no in-person classes.

General Information

- Zoom links are provided after registration and emailed again on the class day.
- Full attendance on both days is required to earn CEU credits. Partial attendance does not qualify; missing a day means the participant will not receive credit and must register for a future session.
- Credits are reported to CE Broker within 72 hours (3 business days) after completion, and certificates of attendance are emailed to participants.
- These webinars count only as LIVE hours. Participants needing NON-LIVE hours must complete those separately.
- It is recommended not to use a phone for accessing the Zoom webinar.

Registration, Payment, and Refund Policy

- Cost: \$249 per session.
- Refunds: No refunds are available.
- After registration, session changes are not permitted.
- Both days must be attended to receive credits; partial attendance will require re-registration for another session.

- Attendance will be verified both mid-session and at the end of each webinar day.
